
We value and encourage teamwork, and we are gaining a reputation for being able to work really well with other organisations, thanks to driving innovation and delivering safety in a highly professional way.

Pension

More than just a standard pension scheme

In the Civil Service, we are renowned for how great our pension is. Our pension administrator, MyCSP, offers an industry leading pension scheme. As a new starter, you are automatically enrolled into the 'Alpha' scheme but can move to an alternative scheme if requested.

The employer contribution towards your pension is extremely generous - on average 27% of your pay.

But what does this actually mean?

Let's say your salary is £22k pa (per annum). If you retire after 20 years' service you could receive an annual pension of £10,208 or a pension of £6,562 pa and a tax-free lump sum of £43,748.

Work-Life Balance

At the MCA we are a community and we understand that creating a good balance between work and personal life is important. We offer a number of attractive options to help promote a positive balance between the two.

Generous parental leave arrangements

Subject to meeting eligibility criteria, the primary carer is eligible for 52 weeks of leave comprising of 26 weeks full pay, followed by 13 weeks statutory pay and 13 weeks unpaid leave. The secondary carer is eligible for 2 weeks of full pay on Paternity leave. Shared parental leave – up to 24 weeks full pay – is also available for eligible employees.

Generous holiday allowance

25 days of annual leave, increasing by 1 additional day for each year of service up to a maximum of 30 days after 5 years of service. Plus 8 bank holidays (based on the England and Wales dates only) and a Privilege day for His Majesty the King's birthday.

Flexible Working

Alternative working patterns, which include full time, part time and shift working, including:

- Flexi-time
- Flexible retirement
- Career breaks
